

Safe Operation Instruction

BORSOG ONE

Provided that you follow this instruction, the cart's operation will be safe.

The cart is to be used for the short-distance transport of equestrian equipment, on the premises of equestrian centres, stables and sports centres, as well as within any other areas used as the place of equestrian recreational centres and/or sports centres, following the conditions below.

1. Technical properties

Model: BORSOG ONE

Dimensions when folded: 63cm x 46cm x 25 cm Dimensions when unfolded: 105cm x 56cm x 120cm Weight: 18.5kg without hangers; 22.5kg with all hangers

Maximum load: 50kg

2. Product's properties

Stable and solid construction: colourised aluminium performance, stainless steel. 4 pumped wheels: fixed front wheels, turning back wheels.

3. Pierwsze użycie



Before the first use, read the Preparation for operation instruction and this instruction for safe operation, especially the requirements and warnings.

4. Use for its intended purpose

The cart may be used only for its intended purpose, with the maximum of its intended load. Any other use beyond its defined scope will be recognized as unintended use and will result in loss of guarantee rights. The user, not the producer, is responsible for damage to body and property caused by an inappropriate use of the cart.

Warnings



The cart MUST NOT be used for transporting people or animals.



The cart is intended for people of 130cm and above, shorter children may use the cart only under adult supervision.



The maximum load of the cart must be followed strictly. Otherwise, there may occur a damage not covered by the guarantee, or injuries.



The break should be locked at all times when the cart is standing still. It should apply especially when there is a fixed trough, or there is a loading or unloading process, as well as when it is being folded or unfolded.



The cart must not be left unattended on sloping grounds, especially with the released break.





Lifting the front wheels by pushing downwards the handle is forbidden. When overcoming obstacles and when driving up a step, the cart should be pulled behind the person.



The cart is unintended for driving in mud which is higher than 1/3 of the wheel's diameter.



Place the cart along the wall of the stall so that the saddle pads hanger is next to the wall, parallelly to it.

5. Maintenance and repair



In order to wash the cart, all you need is water. In case of more dirt, you can use neutral detergents or wash the cart at a carwash paying attention to the sand left in the wheels, hinges and other hidden places.



If the screws are loosened, they must be screwed back. Other repairs or alterations violate the Guarantee Conditions.

6. Proper utilisation of the packaging and the product



The packaging is 100% recyclable, however it is recommended to leave it for the duration of use in order to use it safely for service transport.



The product should not be removed with other household waste.

In order to avoid adverse impact on environment and peoples' health, this product should undergo responsible recycling according to the local law, or it should be returned to the producer.
